## Lemont Park District Splash Party Rental Rules

1. Weather information: No refunds will be made one hour after the start of the rental. If weather is in question a decision by the contact person listed on the contract and or the Aquatic Director to hold the party must be made prior to the start time for a refund to be issued. After one hour into the rental any weather cancellation will result in NO refund. The aquatic supervisor or manager on duty has the right to cancel a party at any time due to weather. If weather is in question we will make every effort to contact you at the phone number(s) provided.
2. For any reason the pool has to be closed due to an individual in your group getting ill in the pool there will be NO refund granted and the pool must shut down immediately.
3. Rental fee MUST be paid in advance at the time the Pool Rental Request Form is submitted.
4. The two hour time slot includes set-up and break-down time.
5. Reservations are on a FIRST COME-FIRST SERVE basis.
6. Any persons known or suspected of having communicable disease shall not use the pool.
7. Running, Boisterous or Rough play is prohibited.
8. Spitting or blowing the nose in the pool is prohibited.
9. Lifeguards have the authority to enforce all pool rules. Patrons who repeatedly violate the rules may be asked to leave the pool.
10. No alcohol is permitted inside or outside the pool area. Persons who seem intoxicated deemed by the manager or in the possession of alcohol will be immediately ejected from the facility.
11. Management reserves the right to implement new pool rules without notification.

All Facilities of the Lemont Park District are Tobacco/Smoking Free environments. All fees are due upon reserving the facility. No alcohol is permitted on the premise inside or outside of any park district facility without the consent. Persons using the park district facilities will be charged for damage done to park district property and equipment. All renters reserving facility space must provide adequate supervision (in addition to lifeguards). Additional charges occur due to repairs, clean-up and service requested above and beyond the initial rental fee.
