STAFF AND COMMITTEE REPORTS -

EXECUTIVE DIRECTOR'S REPORT -

- L. Egofske thanked Commissioners and staff for their work and presence at the Field 32 Opening.
- L. Egofske gave an update on Derby Farms Park including adjustments to amenities that had to be made to meet MWRD requirements for drainage. Commissioner Mescher asked if there is anything that we could do with the open space? Egofske explained that the MWRD requirements are driving the need for permeable space. Several commissioners stated that the open space is ok and needed.
- L. Egofske stated there is a meeting on May 6 for the Cook County Highway and the Grand Prairie Water Commission.
- L. Egofske stated the Cook County Election results are in process and we should be able to ratify the results at our next board meeting.
- L. Egofske gave an update on the status of the financial audit.
- L. Egofske informed the Board that she was asked to participate in an initiative with The Lemont Clergy Committee. The goal is to bring awareness to the mental health of teenagers. The book being discussed is "The Anxious Generation" by Jonathan Haidt

Commissioners congratulated L. Egofske on the invitation to the Women to Watch event. Discussion regarding the event was had.

Commissioner Scarlati asked about the silo at Derby Farms Park. L. Egofske explained some of the options regarding the silo.

RISK MANAGEMENT/HUMAN RESOURCES REPORT - Staff had nothing to add to their report.

INTERGOVERNMENTAL – President McAdam stated that he and Commissioner Scarlati met with officials from the Village of Lemont regarding the viaduct project adjacent to Athens Park. President McAdam gave an update about the status of the project. Constant communication regarding the project with the park district and the village will continue.

- L. Egofske reported that Chief Maton from the Lemont Police Department is retiring. A replacement has not been announced yet.
- L. Egofske explained the Ancel Glink waiver and indicated that it will be presented for approval next month.
- L. Egofske stated that Superintendent Ticknor, from the Lemont High School, has asked for someone to take the lead on the Lemont Tax Consortium. L. Egofske indicated that she will not be taking the lead on for the consortium.
- L. Egofske gave an update on the Village of Lemont ADA Transition Plan. Egofske mentioned there is a survey that has gone out to residents. There are several crosswalks proposed that would make it easier for residents to access parks, downtown Lemont, and other access points.

MARKETING REPORT – L. Raspanti stated there has been two mailers that has gone out to residents. She also reported that the Quarryman Challenge Race is coming up on May 10th and that registration is currently up by fifty runners when compared to 2024.

RECREATION REPORT – Staff had nothing to add to their report.

FACILITIES, FITNESS, AND AQUATICS REPORT – Staff had nothing to add to their report.

MAINTENANCE REPORT – K. Murray updated the Board on the Gleneagles water fountain project. He also reported that Athens Park construction has been mobilized. Discussion regarding where some of the paths and grass surfaces are and/or will be was had.
