
ACTION ITEMS

STAFF AND COMMITTEE REPORTS

Executive Director's Report

L. Egofske commended staff on reorganization and thanks the staff for their hard work getting ready for the season.

Commissioner Richmond commented on the positive move towards the Derby Traffic signal. L. Egofske commented that the meetings with agencies are being set, and the Village is taking the lead with the traffic light engineering.

L. Egofske will move forward with the park plan for Derby and Brusseau will present at the July meeting. Commissioner Scarlati asked if a temporary light will happen before the water project goes through before the park is open.

Commissioner Richmond asked about the state of the park once the water project goes through. L. Egofske is working with the Village to prepare a memorandum of understanding to request timing to ensure and uninterrupted park season.

Commissioner Scarlati suggested that the pipe be changed to 143rd Street with widening project, suggesting Louise contact Village officials.

- L. Egofske confirmed that Athens paving continues on the north side of the park dependent on weather; she continues working with contractors and architects on the wetlands; landscaping is progressing.
- L. Egofske noted that Cathy Morava, a long-time site coordinator and manager for SEASPAR is retiring at the end of June.

Commissioner Scarlati noted the improvements on the plans for the refuse area at the Centennial Community Center. L. Egofske will share those building plans with the rest of the board.

Risk Management/Human Resources: Staff had nothing to add to their report. L. Egofske recognizes Christine's working on OSLAD grant follow up and management

Intergovernmental: L. Egofske commented that things are moving slowly on underpass/bridge project.

Marketing & Community Engagement: Raspanti added updates regarding Athens signage and naming, she's requested the Board members select top three names for dog park and send to her for the public to vote on the final name; The history sign for Athens will be a three-paneled, double sided metal content from Jason Smith - and being built as permanent fixture; Park Foundation working on dog park memorials - steel bones posted on the fence.

Recreation, Facilities & Fitness: G. Hooper noted this is training week, during the days for lifeguards, evenings for day camp counselors; The pool is opening on Friday. Fitness is getting new TVs, working on installation date. Commissioner Scarlati asked if there will be the ability to link to the TVs via Bluetooth. Commissioner Richmond noted the new equipment is nice and congrats to R. Ladner, recently elected the President Elect of SSPRPA. G. Hooper and C. Aguirre noted the meetings with Lemont Baseball and Softball and Lemont Lightning and their plans are moving forward - putting out a survey to coaches regarding Bambrick Park L. Egofske commented the policies on fields for recreation vs. travel will be updated and programming will be more defined by the park district; Commissioner Scarlati noted that Lemont Baseball and Softball Club is willing to work with Parks and has ideas as well.

Maintenance: K. Murray noted the drinking fountain for Gleneagles is complete and up and running "tastes good."
