Waiver and Release

Lemont Park District is dedicated to conducting its recreation programs and activities in a safe manner, prioritizing participant safety at all times. We continuously work to minimize risks and require all participants to adhere to safety rules and instructions designed to protect their well-being. However, participants and parents or guardians of minors registering for activities must acknowledge that there is an inherent risk of injury associated with recreational activities.

It is your responsibility to determine if program offered by Lemont Park District are suitable for you or your child. We strongly recommend consulting a physician before engaging in any physical activity, especially if the participant is pregnant, has any disabilities, or has recently experienced an illness or injury.

Lemont Park District is committed to inclusivity and welcomes the participation of individuals with special needs in all programs, activities, and services. If you or someone you know requires special accommodations to participate in a program, please notify the Recreation Supervisor responsible for that activity. We will do our best to meet those needs, but please be aware that securing accommodations may take 10 to 20 business days.

Warning of Risk

Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity/program. Understandably, not all hazards and dangers can be foreseen. Participants must understand that certain risks, dangers, and injuries due to acts of God, inclement weather, slipping, falling, equipment failure, failure of supervision, premise defects and all other circumstances inherent to recreational activities/programs exist. In this regard, it must be recognized that it is impossible for the Lemont Park District to guarantee absolute safety.

Waiver and Release of All Claims and Assumption of Risk

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity (including transportation vehicles when provided.)

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the Lemont Park District, including its officials, agents, volunteers and employees (hereinafter collectively referred as Lemont Park District.)

I do hereby fully release and forever discharge the Lemont Park District from any and all claims for injuries, damages or loss that my minor child/ward or I may have, or which may accrue to me or my minor child/ward and arising out of, connecting with, or in any way associated with this program/activity. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims.

If registering a minor participant, I further attest that I have read the above to my minor child/ward. Any faxed registration forms/signatures will be considered the same as an original form/signature. Participation will be denied if the signature of an adult participant or the parent/guardian are not on the front of this waiver. Participation will be denied if the signature of an adult participant or the parent/guardian is not completed.

If registering online or via fax, my online acceptance or facsimile signature shall substitute for and have the same legal effect as an original form signature.
