**AUTHORIZING THE TENTATIVE FORM OF BUDGET AND APPROPRIATION ORDINANCE  
FOR FISCAL YEAR 2025 TO BE MADE AVAILABLE FOR PUBLIC INSPECTION AND  
SETTING FORTH DATE FOR PUBLIC HEARING ON SAME**

WHEREAS, Section 4.4 of "The Park District Code" requires that a budget and appropriation ordinance shall be prepared in tentative form by some person or persons designated by this park board, and in such tentative form to be made conveniently available to public inspection for at least 30 days prior to any final action thereon by this board and that a public hearing concerning said ordinance be held with proper notice to the public; and

WHEREAS, the executive director of this Park District, at the direction of this park board, has prepared such a budget and appropriation ordinance, in tentative form.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF PARK COMMISSIONERS OF THE LEMONT PARK DISTRICT, as follows:

- Section 1. That the attached Budget and Appropriation Ordinance for the Fiscal Year **2025** shall be made conveniently available, in such tentative form, to public inspection for at least 30 days prior to final action thereon following a public hearing conducted by this park board as to such Budget and Appropriation Ordinance to be held on the **10<sup>th</sup> day of December, 2024 at the Lemont Park District Canal Center / Safety Village, 55 Stephen Street, Lemont, Illinois at 6 p.m.**
- Section 2. Notice of said public hearing shall be given by publication in a newspaper published in this Park District at least one week prior to the time of such hearing.

BUDGET AND APPROPRIATION ORDINANCE

AN ORDINANCE ADOPTING THE COMBINED ANNUAL  
BUDGET AND APPROPRIATION OF FUNDS  
FOR LEMONT PARK DISTRICT  
COOK, WILL AND DUPAGE COUNTIES, ILLINOIS  
FOR THE FISCAL YEAR  
BEGINNING JANUARY 1, 2025 AND ENDING DECEMBER 31, 2025

BE IT ORDAINED BY THE LEMONT PARK DISTRICT  
BOARD OF COMMISSIONERS, COOK COUNTY, ILLINOIS.

Section 1: It is hereby found and determined that:

a) This Board has heretofore caused to be prepared a combined Annual Budget and Appropriation in tentative form, which Ordinance has been conveniently available for public inspection for at least 30 days prior to final action thereon; and

b) A public hearing is scheduled to be held at the Lemont Park District Canal Center / Safety Village, 55 Stephen St., Lemont, Illinois on December 10, 2024 on said Ordinance, notice of said hearing having been given at least one (1) week prior to such hearing by publication in a newspaper published within the District; and

c) That all other legal requirements for the adoption of the Annual Budget and Appropriation Ordinance of the Lemont Park District for the fiscal year beginning January 1, 2025 and ending December 31, 2025 have heretofore been performed.

Section 2: The following sums of money, or so much thereof as may be authorized by law for the following objects and purposes, be and the same are hereby budgeted and appropriated for the fiscal year beginning the first (1st) day of January, 2025 and ending on the thirty-first (31st) day of December, 2025:

Each of said such sums of money and the aggregate thereof are deemed necessary by the Board of Parks Commissioners of the Lemont Park District to defray the necessary expenses and liabilities of of this District during the fiscal year beginning January 1, 2025 and ending December 31, 2025 for the respective purposes set forth.

All unexpended balances of the appropriation for the fiscal year ending the 31st day of December, 2025 and prior years are hereby specifically re-appropriated for the same general purposes for which they were originally made and may be expended in making up any insufficiency of any other items provided in this appropriation ordinance, in making this appropriation in accordance with applicable law.

The receipts and revenue of said District derived from sources other than taxation and not specifically appropriated, shall constitute the general corporate fund and shall first be placed to the credit of such fund.

Section 3: The following determinations have been made and are hereby made a part of the aforesaid budget:

Section 4: The receipts and revenues of the Lemont Park District derived from sources other than taxation and not specifically appropriated and all unexpended balances from the preceding fiscal year not required for the purposes for which they were appropriated and levied, shall constitute the General Fund and shall first be placed to the credit of such fund.

Section 5: All ordinances or parts of ordinances conflicting with any of the provisions of this ordinance be, and the same are hereby, repealed to the extent of such conflict. If any item or portion thereof of this budget and appropriation ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining portion of such items or the remaining portion of this ordinance.
